What is the Water Efficiency Fund?

Business Stream will allocate £100k every year to our Public Sector Scotland Water Efficiency Fund. This fund has been set up to help public bodies across Scotland deliver water efficiency projects and realise the environmental and associated financial benefits. This fund is provided as part of the framework and supports our commitment to make a positive difference for our customers and the environment.

How to apply

You can apply for the fund by completing a Water Efficiency Fund application form and returning it to solutions@business-stream.co.uk or to PSS team, 1-3 Lochside Crescent, Edinburgh, EH12 9SE.

Qualifying criteria

To qualify, projects must:

- be for a public body that is on the framework,
- cover only public sector sites and,
- reduce water use.

How projects will be selected

Applications will be reviewed by the Fund Allocation Panel.

The fund allocation process will be overseen by nominated representatives from Business Stream, public bodies and Scottish Procurement.

This group will ensure that funding decisions are transparent, fair and adhere to qualifying criteria.

What are the rules?

- There is no cap on the number of applications a public body can submit.
- Projects will be picked on the basis of cost versus benefit, and will focus on environmental and financial return on investment. Submissions must include a full scope of the proposed project.
- To ensure the maximum number of bodies benefit, the Fund Allocation Panel will balance return on investment against the number of participating bodies.
- Public Bodies can choose to have Business Stream implement the project or, if more appropriate, Business Stream can provide the water efficiency devices and the public body may use their own facilities team for implementation.
- Business Stream can provide funding for projects that will be delivered by a third party. Please provide a fully scoped proposal from the relevant supplier.

How the fund will be managed

• Business Stream will invest £100k annually in the Fund.
